

BIBLIOGRAPHY OF UNUSUAL APPLICATIONS OF PRICE THEORY, A NOTE

Social scientists, sociobiologists and philosophers intending to evaluate, extend or teach the new applications of price theory should find the following pages a useful research resource. The aim is to bring together references to the more unusual applications, so areas in which a substantial literature has appeared are under-represented in this list. Such areas include: cliometrics,¹ economics of the family,² public choice,³ and economics of crime.⁴ No judgment of quality is implied by inclusion in the bibliography. The only criterion for inclusion is that the publication make a substantial (though not necessarily formal) application of neoclassical price theory to some subject matter usually considered outside the domain of economics.
